# CONDUCTING RISK ASSESSMENTS FOR CRITICAL COMMUNITY ASSETS

## MGT-315

The purpose of this course is to help prevent, reduce, or mitigate the potential consequences of a domestic terrorist attack, natural catastrophe, or other emergency using all-hazards scenarios to identify critical community asset risks and their potential impacts to a community. The information gained through the application of these training concepts may be used to develop appropriate action plans to reduce consequences and manage risks. This course provides training to assist emergency responders and other local stakeholders (operating as a multidisciplinary team) in analyzing existing security measures and formulating a strategy for mitigation.

The course will assist local emergency responders and stakeholders in identifying critical infrastructure sectors that may be at risk in their community and aid them in the development of mitigation strategies that can lessen the community impacts. Using locally relevant all-hazards threats and hazards to gauge the community's capability to prevent, prepare for, mitigate, respond to, and recover from a significant event, this course enables responders, local public officials, and private sector stakeholders to prioritize their mitigation efforts where they are needed most. This course has links to both the Threat and Hazard Identification and Risk Assessment and Stakeholder Preparedness Review (THIRA/SPR) course (MGT-310) and Continuity of Operations (COOP) or Continuity of Government (COG) planning
